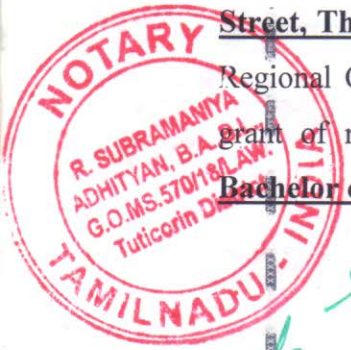

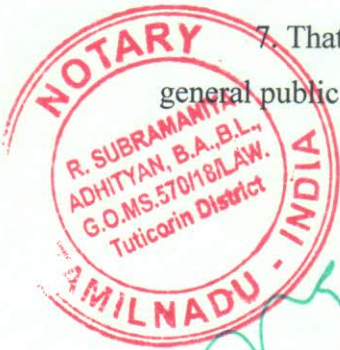

6. That the said premises shall not be used for running any educational activity/institution, other than the teacher education programme for which recognition is being sought.


